INFORMATIVE in accordance to art. 13 of Legislative Decree 196/03 and ex art. 13 of the EU Reg. 679/2016

To whom it concerns,

we wish to inform you about the treatment that will follow the sending of data.

In summary, Centro Teleinform Italia s.r.l. (VAT No. IT 09495120157), hereinafter Teleinform, will process your data solely for the achievement of the purposes described below and to comply with current legal obligations, ensuring that the processing will take place, whenever possible, in an anonymous way and, in any case, according to the principle of necessity, in order to ensure that the data are processed only when necessary and by the minimum number of people technically possible.

MAIN PURPOSES:

Teleinform processes the data for the pursuit of the following purposes:

- 1) Business Information
- 2) Investigations
- 3) Debt collection
- 4) Patrimonial tracing
- 5) Nando rating

Purposes 1 and 2 are frequently associated, as well as purposes 3 and 4 are.

With reference to commercial information and investigations, the data will be processed in compliance with the deontological codes approved by the Guarantor and the general measures published. The nature of the processing is optional, the conferment is mainly done by our customers who ask us to provide information search services. The data is integrated manually, by our operators, through searches and access to third-party databases to create a complete file on the person or company. In addition to information received from customers, all data is public and is extracted from public records (consistent with the purpose of publication) or is provided voluntarily by the interested party. This activity is provided in the name and on behalf of our clientele to whom the co-ownership of the processing is responsible and, in particular, the definition of the authorization profiles and the legitimacy to the treatment. Teleinform is entitled to make choices regarding the protection of the data processed and the reply to the interested party.

All the activities of Teleinform are carried out under license and prefectural authorization (pursuant to articles 115 and 134 of the Consolidated Law on Public Security Laws) and are subject to the respective regulations.

ANCILLARY PURPOSES:

data sent, either through the website or by email, by phone, by traditional mail or in any other way, will be processed for all legal obligations (anti-money laundering, quality, safety, tax, accounting, etc.) and for the purposes described above.

RECIPIENTS:

the data collected, in the personal form and associated with a single individual, will be processed only by internal personnel or technical partners appointed as data controllers, as well as with our client, in the name and on whose behalf the data are processed. The same data, only after being anonymized, can then be shared with third parties. There is no automated data processing, but only traditional treatment based on technological means and tools.

LEGAL BASIS OF TREATMENT:

for Teleinform, each treatment has a legal basis or a legal obligation (such as, for example, identification treatments for anti-money laundering) or in a contractual relationship and the commitment to provide a service, consisting of different activities of data processing, in the name and on behalf of a customer.

TRANSFER OF DATA ABROAD:

the data will not be transferred abroad.

WARRANTIES:

anyone has the right to access the processed data, to obtain a copy, to confirm the existence, to rectify the content or request its cancellation, to oppose or limit its processing. The exercise of any other right provided by law, such as the portability of the data, is guaranteed.

In the event of opposition to the processing or revocation of consent, the deed does not prejudice the compulsory treatment by law, data treatments rendered anonymous and treatments already performed at the time of the request for revocation. The acquisition of both sensitive data and information covered by company and industrial secrecy is excluded.

STORAGE:

the retention time of personal data is 10 years for the main purposes and for the accessory purposes.

CONSENT:

The data provided may be processed without consent in accordance to the art. 9, comma 2 lett. b) d) e) f) as well as to paragraph 3 of the same article of EU Regulation 679/2016.

COMPLAINT:

If you wish, you can consult the Privacy Guarantor (<http://www.garanteprivacy.it/>) to propose a formal complaint.

OBLIGATORINESS:

The provision of data is not mandatory by law. Failure to provide it has no consequences of any kind.
